## Job Opportunity: Cultural Resource Specialist

Bat Conservation International (BCI), a 501(c)(3) nonprofit organization dedicated to ending bat extinctions worldwide, seeks a full-time Cultural Resource Specialist to join BCI's Conservation Department. The Cultural Resource Specialist will work as part of the Restoration Team in the Habitat Protection & Restoration Program (HP&R).

Status: Full-time, exempt

Reports to: Cultural Resource Field Lead (Autumn Cool)

Key Relationships: Restoration Team, Habitat Protection & Restoration Program,

Conservation Department

Salary: \$55,000- \$58,000 per year

The successful candidate will work directly with BCI's Cultural Resource Field Lead to document and analyze archaeological sites, primarily historic-period abandoned mines. This includes writing archaeological technical reports, completing cultural resource inventory forms, and conducting fieldwork on public lands throughout the southwest United States.

BCI's cultural resource inventories are done in combination with subterranean bat surveys to gather information on both wildlife and cultural resources at abandoned mines. The inventories are used to guide treatment recommendations to protect important cultural and biological resources during safeguarding and closure of abandoned mines on public lands. In the future, BCI's cultural resource inventories may also include surveys of areas selected for wildlife habitat restoration projects. Additionally, this position will assist with other project duties, including data and photo organization, map production, conducting research, and other tasks.

Our program highly encourages all staff to seek out opportunities within other teams and specialties to better understand the full capacity of the HP&R program and to build working relationships with colleagues outside of their respective specialties and teams. The ideal candidate will be willing and able to provide technical writing and fieldwork assistance to other teams within HP&R during lulls in cultural resources work. BCI offers on-the-job training, and opportunities for additional safety/medical certifications may be available. Traversing challenging terrain on foot and conducting surveys in inclement weather is a part of all field-based work within HP&R.

The EEB <u>Water</u> Working Group works on maintaining an ambitious EU Water Framework Directive.

Topics of interest to the group include:

# 5th International Meeting of Cavers in the Moravian Karst: Karst, Caves, And People 2023

This 2<sup>nd</sup> Specialized Conference will occur on September 20 – 24, 2023 in Sloup, Moravian Karst, Czech Republic. In 2023, we celebrate the unique achievement that happened 300 years ago! Lazarus Schopper, the Provincial Superior of the Minority Monastery in the city of Brno, was the first one to descend into the Macocha Abyss. In 1723, he was dropped in wicker basket into the abyss, 138 m below the surface. At that time, such a unique action attracted the interest in caves in the Moravian Karst area.

This anniversary coincides with another—the 45th anniversary of the foundation of the Czech Speleological Society. Since 1978, the Czech Speleological Society has been connecting together successors of the brave monk—cavers who

represent the largest and most important speleological community in the Czech Republic. On the occasion of these anniversaries we offer excursions into the most significant sites of the Moravian Karst and call for presentations related to human activity in the karst regions.

## Call for Presentations: Survey and Cartography Session, 2023 NSS Convention, West Virginia, USA

This is a call for presentations for the Survey and Cartography session at the 2023 National Speleological Society (NSS) Convention, planned for 26-30 June 2023 in Elkins, West Virginia, USA. The session provides a good way to tell other cave mappers what you are doing, and to discuss problems related to mapping and cave surveying. Most cave surveyors have either developed useful techniques that may benefit others, or are encountering problems that someone else may have solved. In either case, a session presentation would be appropriate.

The session is informal and the audience is friendly. There are no requirements to provide fancy visual aids or to provide a written paper (other than an abstract to include in the Convention's *Program*). Most presentations are scheduled for 15-20 minutes, but this is very flexible and can be changed to accommodate the presenter. The session will be on Friday afternoon, June 30.

Presentations can be on any topic related to any aspect of cave mapping, and the material can be for folks with any level of mapping experience. A partial list of potential presentation topics includes:

- How to keep cave mud off your survey instruments (while still going into the cave)
- Tips on the care and calibration of electronic survey instruments
- How to resolve blunders without another trip to the cave

- Large project management (personnel, survey standards, data processing, etc.)
- New tools, toys, or software to aid in mapping or cartography
- Representing complex vertical caves on a 2-dimensional map
- Demonstrations of techniques for improving efficiency when drafting maps on a computer
- Comparison of various programs for survey processing, map drawing, and data visualization
- Integrating cave survey data with surface and GIS data

The above list is obviously incomplete. If you are doing something that you think would be of interest to other cave surveyors, please consider doing a presentation on it. We are also open to suggestions for topics for an "open discussion" to solicit input from the session attendees.
